## WELDON, N. C.

Weldon, the county seat of Roanoke County, is situated at the junction of the Wilmington and Weldon, Raleigh and Gaston, and Petersburg and Weldon Railroads. The Junction Depot is a large building, and, considering the size of the village, may be truly said to be of an imposing appearance. The Roanoke river runs within 300 yards of the village. Weldon is distant (by railroad) 97 miles northeast of Raleigh, 63 miles south of Petersburg, and 162 miles north of Wilmington. Population, 1,000.
